Ref: 1. This office letter No. 145-E/SCT/Reservation Policy/Promotion/2025 dated 29.05.2025.

- 1. As per extant guidelines and practice, SC/ST community candidates being promoted on own merit (Not owing to reservation) are adjusted against UR roster point wherever such promotions are through 'Selection'. In the case of promotion through 'Non-Selections' (Such as Suitability test and trade tests) however, the practice over the Railway in presently not uniform. While in some Divisions/Units the SC/ST candidates coming in on own merit (not owing to reservation) are adjusted against UR Points, in one Division/some units such candidates are still being adjusted against SC/ST Points. The All India SC/ST Association, NCR, has also represented on this matter.
- 2. To clarify the matter and to have uniformity of interpretation of reservation Policy on this aspect, a reference was made to Railway Board (Ref:-1 above). Vide reply dated 30.05.2025(Ref:-2 above), Board have clarified that adjustment of SC/ST candidates selected on own merit (not owing to reservation) against UR Points is applicable in promotions irrespective of 'Selections' and Non-Selection posts.
- 3. All Divisions/Units of the Railway may be guided accordingly.
- 4. Past finalized cases need not be reopened on this account.
