Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra on & behalf of the President of India invites Expression of Interest (E.O.I.) on prescribed Application from **for empanelment of CGHS/ ECHS/ESIC empanelled hospitals or any other PSU hospital or Charitable hospital for cashless treatment of Railway beneficiaries of North Central Railways, Agra Division** on CGHS Meerut rates- Non- NABH-2014 rates or their hospital terrific rates whichever is lower on bill system of payment for the period of two years. All the hospitals are advised to carefully go through the instructions, list of enclosures and MOU before filling up the application form. The concerned hospitals should enclose all the required documents along with application form. The incomplete applications & those which are not submitted within the due date will be rejected. The application for empanelment must be submitted in a sealed envelope prescribed as "Application for Empanelment of Hospitals" in office of the Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra before 15hrs.on or before 4 weeks of publication of this advertisement.

All the application will be examined by the office of CMS & those eligible will be informed accordingly. The specialties, for which a hospital will be empanelled with Agra Division, will be as per requirement of Medical Department, Agra Division & decision of CMS/AGC will be final in this case. After selection, hospitals will be have to sign MOU with Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra for providing cashless medical treatment to eligible Railway beneficiaries of North central Railways, Agra Division.

All the empanelment will be done on CGHS Meerut rates- non-NABH-2014 rates or their hospital terrific rates whichever is lower only.

Hospitals, which are already empanelled with Agra Division, need not apply again.

**INSTRUCTIONS TO THE APPLICANTS FOR EMPANELEMENT OF CGHS/ ECHS/ESIC EMPANELLED HOSPITALS OR ANY OTHER PSU HOSPITAL OR CHARITABLE HOSPITAL FOR AGRA DIVISION AS PER CGHS MEERUT RATES- NON-NABH-2014 RATES**

1. All interested CGHS/ ECHS/ESIC empanelled Hospitals or any other PSU Hospital or Charitable Hospital for multi-specialty treatment are invited for the empanelment with North Central Railways, Agra Division on CGHS latest rates (CGHS Meerut Rates- NON-NABH-2014 rates) or their hospital tariff rates whichever is lower.
2. Only those hospitals are to be empanelled which are providing treatment through modern system of medicine i.e. Allopathy.
3. Hospitals should submit their rates for all the facilities/services available with their center.
4. Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra, or any other nominated officers will identify the specialties for which the treatment for the Railway beneficiaries are required from the private hospitals. Even if the CGHS, ESIC & ECHS hospitals are recognized for multi-specialty treatment, the specialties for which they are to be recognized by North Central Railways, Agra Division for treatment of beneficiaries will be decided by the Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra.
5. Hospital must agree to accept the terms & conditions specified in the Memorandum of Agreement, which should be read as a part of the application document. The MOU will be done as per latest direction of railway board. 6. Hospitals must certify that they shall charge as per CGHS latest rates (CGHS Meerut Rates- NON-NABH-2014 rates) or their hospital tariff rates whichever is lower. They have to give an undertaking that the rates charged by them for North Central Railways, Agra Division's beneficiaries are not higher than the rates being charged from General Patients.
7. The hospital should be of minimum 150 beds with 20 bedded ICU and 20 bedded HDU.
8. It should have fully furnished Cancer care unit including PET CT scan, medical oncologist, surgical oncologist, and Radiotherapist (Tumor Board Team).
9. It should have dedicated round the clock available Trauma unit including Neurosurgeon and in house neuroimaging facility (MRI & CT scan)

10. Dedicated COVID facility should be there.
11. Free ambulance services must be provided by the empanelled hospital to Railway beneficiaries.
12. The hospital should certify that no investigation/case by any Central Government/State Government on any statutory investigating agency is pending or contemplated against the hospital. It should have all valid licenses/approval and registered with state authorities.

**13. The Application/EOI must be submitted in duplicate.**

14. Application/EOI forms should be submitted in sealed envelope super scribed as "APPLICATION FOR EMPANELMENT OF HOSPITALS".
15. All the pages of application form and Annexure(s) (each Sheet) should be serially numbered.
16. Every page of Application form and Annexure(s) need to be signed by the authorized person. The signatory must mention as to whether he/she is the sole proprietor of authorized agent. In case of partnership, a copy of the partnership agreement on stamp paper duly attested by a notary should be furnished. Similarly, in case of authorization, appropriate legal document should be furnished.
17. Application/EOI for empanelment must be submitted in the tender box placed at the office of the Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra. Application/EOI received after the due date & time will not be considered and the application can also be sent by the registered post at the following address:

18. As far as possible, all information should be given in the application. If a particular facility is not available, it should be entered as "Not Available" and not as "Not Applicable".
19. Submission of application does not mean that hospital is empanelled with Railways. The empanelment will be done as per need of Railway administration and fulfilling all conditions decided by Railway administration.
20. Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra reserves the right to reject/cancel the process of empanelment of hospitals at any time without thereby incurring any liability to the affected hospital/authorized representative/service provider on any obligation to inform that affected hospital/authorized representative/service provider on the ground for his action.

21. Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra reserves the right to accept or reject any application at any time without thereby incurring any liability to the affected hospital/authorized representative/Service provided on any obligation to inform the affected hospital/authorized representative/service provider of the grounds for his/her action.

22. Every application must be accompanied by copies of required documents.

23. Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra reserves the right to inspect the hospitals at any time to ascertain their compliance with the requirement of Railways.

24. The rates shall continue to hold good unless revised by CGHS, Ministry of Health & Family Welfare. In case the notified rates are not acceptable to the empanelled private hospital, or for any other reason, the private hospital no longer wishes to continue on the list of empanelled private hospital, it can apply for exclusion from the panel by giving one months' notice.

## 25. SCRUTINY OF APPLICATIONS

- a) All the applications will be opened in office of the Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra.
- b) Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra or its nominated officer will examine the application to determine whether:
  - i. Whether they are complete.
  - ii. Whether any computational errors have been made.
  - iii. Whether the documents have been properly signed and serially numbered.
  - iv. Whether the application is in order.
  - v. Only those applications that are found to be complete in all respects shall be accepted for consideration of empanelment.
  - vi. Every page of tender documents and other documents which are to be submitted with the application must be signed otherwise liable for rejection.

26. After the Hospital is found eligible for empanelment, it will be informed about that by Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra & they will have to enter MoU with Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra after submission of performance bank Guarantee as decided by Railway Board.

27. The contract will be renewed after the end of empanelment period on satisfactory performance of the hospital.



28. The Hospitals would be recognized for a period of two years or till it is empanelled under CGHS/ECHS/ESIC or whichever is earlier. The empanelment will be extended after satisfactory performance of the hospital. In a situation, when any hospital is de-empanelled by CGHS, ECHS & ESIC, the same should be automatically de-empanelled for Railway beneficiaries of Agra Division.
29. The rates to be charged by the empanelled hospitals should be as per CGHS prescribed rates based on the classification of the hospitals (CGHS Meerut Rates- NON-NABH-2014 rates) or the Hospital tariff whichever is lower.
30. If there is no package rates of any procedure/item on CGHS/AIIMS rate list than the rates will be charged as per hospital rates with discount offered by the concerned hospital.
31. Discount on MRP of medicines to be mentioned along with application form.
32. The hospitals which are selected for recognition will have to present the original order of CGHS/ECHS/ESIC (only empanelled hospitals) at the time of signing the MOU with Chief Medical Superintendent, Division Railway Hospital, North Central Railways, Agra.
