In case no reply is received within the specified time limit as mentioned above, it will be presumed that no such record is required by your office and the same will be destroyed without any further reference.

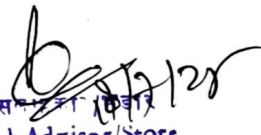
